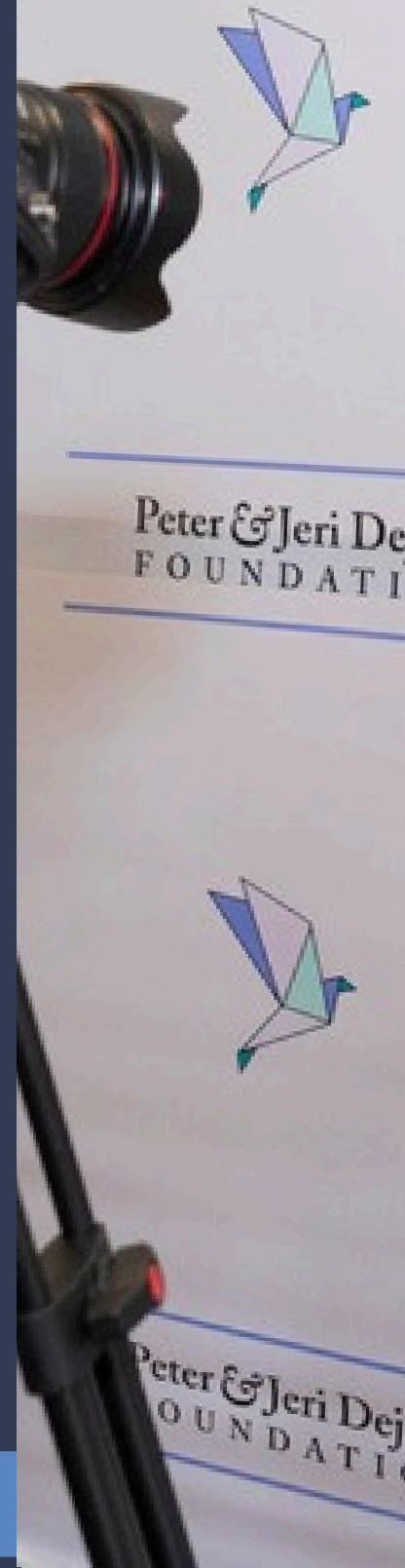

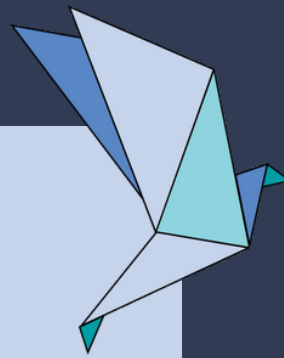

# *Our History*

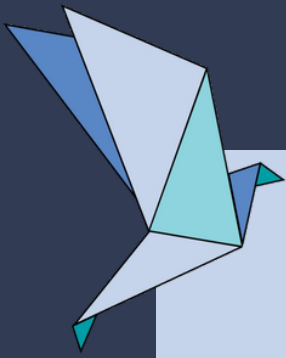


The Peter & Jeri Dejana Foundation traces its origins to the life and work of Peter Dejana, an immigrant entrepreneur whose story is deeply connected to the community of Port Washington. Founded in 2010, the foundation emerged from decades of community involvement and business success. Its mission reflects the values that shaped Peter's life: hard work, commitment to his community, and the belief that prosperity should be reinvested to improve people's lives.



Peter immigrated to the United States in 1955 at the age of 15 from Sardinia, Italy, arriving on the Cow Neck Peninsula with ambitions for a better life. As a teenager, he worked a series of labor-intensive jobs—including landscaping and snow clearing—while learning English and building relationships throughout the North Shore. These early efforts eventually laid the groundwork for a successful career in a myriad of private and public outdoor contract services.

Through the creation of Dejana Industries, Inc. and Aero Snow Removal Corp., Peter & his wife, Jeri, built the largest municipal services contracting operations in North America. The Dejana companies provided essential services across major U.S. cities, including snow removal, highway cleaning, waste disposal, and catch basin maintenance. Peter also advanced the field through innovations such as high-capacity snow melters and improved debris-collection technology.



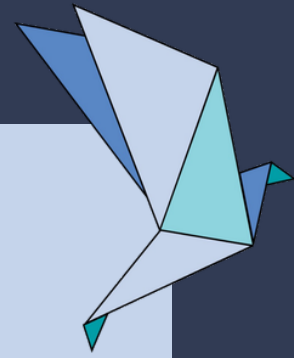
# *A Modern Legacy*



Even as his businesses expanded, Peter never lost sight of his roots. In 2010, Peter and Jeri established the Dejana Family Foundation to support local and regional charitable organizations, with a deep commitment to the Port Washington community. Early philanthropic investments focused on hyperlocal initiatives & institutions that the Dejana family had long supported.

Following the sale of Dejana Industries in 2017, the Foundation expanded significantly, with assets growing to approximately \$80 million. The organization broadened its grantmaking while maintaining a strong commitment to the Port Washington community. Peter remained deeply involved in both his business and philanthropic interests until his passing at the age of 84. After his death, the Foundation was renamed the Peter & Jeri Dejana Foundation, Inc., with Jeri continuing its leadership and charitable mission.

# *A Vision for 2026*



Today, the foundation supports a wide range of causes while maintaining its community-centered roots. As of 2026, the organization has distributed more than \$35 million in grants to hundreds of non-profit organizations.

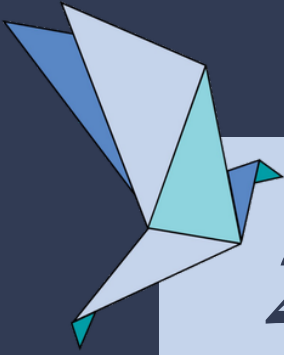

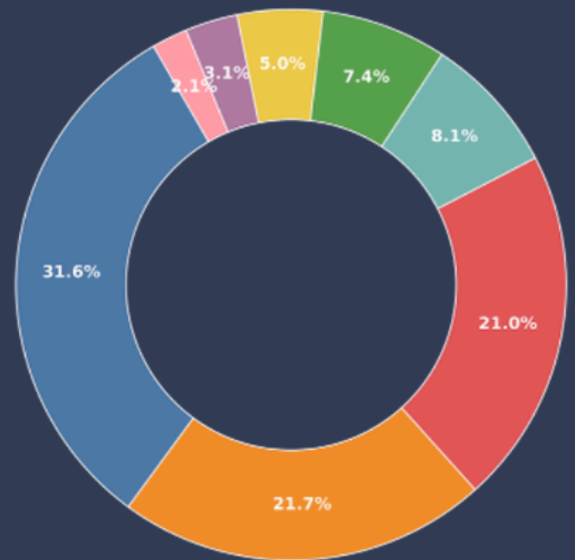

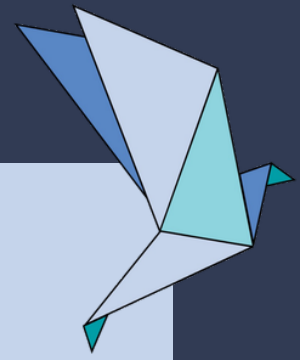

# *Our Values*

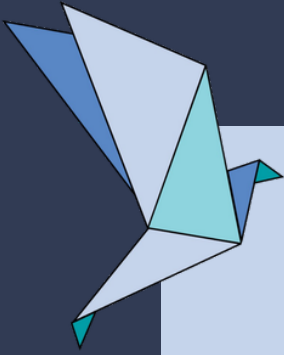

Equally central to our mission is the pursuit of **impact at scale**—efforts that maximize reach and meaningfully improve the lives of as many individuals as possible. We value **authenticity, collaboration, and people-centered partnerships**, and we welcome applicants of all sizes who share these principles.



**Transparency** is essential to our process. We expect applicants to communicate the **full scope of their proposed work**, articulate how Foundation funding will be used, and outline anticipated outcomes from implementation through long-term impact. **Clear, thorough information** enables us to understand a project's potential and strengthens our ability to **invest in efforts aligned with our mission & values**.

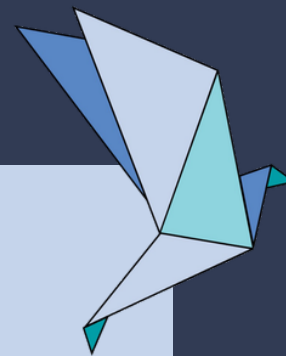

Any 2026 applications submitted **before our Spring Grant Cycle open date** will be considered for the Spring Grant Cycle.

**Small grants (between \$1K-\$75K), time-sensitive events, & sponsorships** may be decided on a rolling basis at the Dejana Foundation's discretion.

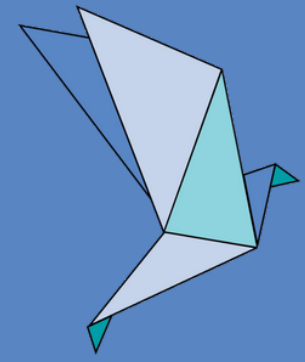
We ask that **returning grantees** still submit an application form for either Spring or Fall 2026.

Spring 2026 applications will be accepted through **traditional form application** accessible via our website. Fall 2026 applications will be submitted through a **new digital software**, Foundant, accessible through our website in Q2.
